1.2. Relevant identified uses of the substance or mixture and uses advised against

Application: Binder for natural and artificially processed aggregates, such as sand and gravel, for production of mortar, plaster and concrete.
'AALBORG WHITE cement made in Egypt' does not contain water-soluble chromium 6+, thus being chromium neutral as no chromium-based raw materials are used in the production. This fulfils EU's demands for a maximum value of 2mg/kg soluble chromium (VI) in cement under normal and dry storing conditions without time limits.
